Sector Programs: Our sector programs provide communities of reflection and practice for leaders in a variety of fields including: education, non-profits, business, healthcare, human services, and religion to support their efforts to work within their communities and professions from a place of greater integrity in ways that are life-giving and renewing for themselves and the people they serve. This year we completed five Flourishing in Ministry cohorts serving over 100 clergy and ministry leaders, culminating with a combined learning conference—our first in-person event post-COVID. A Healing the Heart of Higher Education event hosted by CCR served over 100 educators and leaders. We also offered a Soul of Aging Institute to prepare 30+ alumni of CCR programs to offer our Soul of Aging curriculum in small group settings in their own communities. Our network of Courage & Renewal facilitators offered sector-specific and cross-professional programs engaging new participants and alumni around the world.
